

# **INDEPENDENT AMERICAN CONSERVATIVE**

## **A National Political Action Coalition**

Grass Roots Organization

### **PURPOSE:**

The Purpose of the **INDEPENDENT AMERICAN CONSERVATIVE** coalition is to become very actively involved in restoring the governmental restraints the founding fathers envisioned and built into the Constitution, through active, coordinated involvement in National, Regional, State, & local government candidates, legislation, law suites, judgeships and school boards.

IAC is a grass roots, non-partisan, non-profit umbrella “ACTION” organization (an Independent Political Action Coalition), a national “involvement” (get in the trenches and do what needs to be done) movement that can encompass all people, irrespective of other affiliations, in order to bring about a Conservative reformation. Additionally, it can be a conduit for funding pro-traditional family legislation, and other funding causes, and keep the donors anonymous.

### **NAME:**

The name of this organization is the INDEPENDENT AMERICAN CONSERVATIVE (PAC) and stands for the following:

**INDEPENDENT:** IAC is not affiliated with any political party and therefore free to support any conservative constitutional candidate or cause no matter where they are to be found. This also allows IAC to affiliate with and support any and all other organizations or parties that correspond with its conservative goals and platform.

**AMERICAN:** IAC supports the principle that America should be a completely independent sovereign republic based solely upon its unique and sacred American Constitution and Bill of Rights that encompasses all of it's citizens regardless of ethnicity, religion, cultural, or physical heritage. All Americans should abide by the fundamental sacred oaths of our country, such as **“I pledge allegiance to the flag of the United States of America, and to the Republic for which it stands, one nation, under God, indivisible, with Liberty and Justice for all.”**

**CONSERVATIVE:** IAC believes in the values and intents of the Constitution and the Bill of Rights as they were originally intended. Such original intent has since become identified as conservative values, including those of honesty, integrity, morality, a small and limited government, freedom from excessive taxation, freedom of religion,

freedom of speech, the unrestricted right to keep and bear arms by all law abiding citizens, and so forth.

## **THE INDEPENDENT AMERICAN CONSERVATIVE PLATFORM** **Ideals & Goals of the IAC to work towards in a consistent, prudent manner**

A reformation, or return to the following:

**1. THE CONSERVATIVE CONSTITUTIONAL PRINCIPLES OF LIFE, LIBERTY, FREEDOM, GOVERNMENT, AND LAW** upon which this great Republic was originally founded upon in its constitution and Bill of Rights.

**2. THE VALUES** which sustain and make the Constitution and Bill of Rights a workable government outline including; Honesty, Integrity, Virtue, Morality, Justice, Equality, Truth, Families, God, Hard Work, Accountability, Responsibility.

**3. THE BILL OF RIGHTS AS ORIGINALLY INTENDED**, including; Freedom of Religion (the government will make no law in support of or against a religion), Freedom to Bear Arms, (all law abiding citizens have the right to own arms and ammunition without government intervention), Freedom of Speech, Freedom of Peaceable Assembly, and so forth.

**4. A SMALL AND LIMITED FEDERAL GOVERNMENT** as outlined in the constitution. All powers not specifically detailed in the constitution for the Federal government are to be given solely to the states. Therefore, this includes a reduction of all Federal agencies and the elimination of the Education Dept, Energy Dept, Health and Human Services Dept, Housing & Urban development Dept, Dept of Labor, and many of the Independent Federal Agencies including the US institute of Peace, and Legal services corporation. Also, the re-establishment of the balance of power between the Federal Executive, Legislative and Judicial branches, the repeal of all Executive Orders and the power to make them, and the repeal of the Judicial Branch to enact laws.

**5. A FREE MARKET SYSTEM** based upon the private ownership and personal control of such private property. This includes the concept that Federal & State governments should not be in ownership of private business, or be in competition with private business. Therefore they should not be involved in, or fund, banking, health care, auto industry, art groups, ACORN, etc. This would include the elimination of Fanny Mae & Freddie Mac for example. This also belies the fact that there is no such thing as a private company too big to fail.

**6. BALANCED FEDERAL AND STATE BUDGETS**, Which includes prudent fiscal restraint, the elimination of the practice of borrowing monies by the federal government, as well as the elimination of the federal debt. No federal monies are to be spent on any building project in any state without the approval of a majority of states approving said expenditure, except if said expenditure is for national

security/defense.

**7. THE ELIMINATION OF THE FEDERAL RESERVE**, and the return to the printing of money which is backed by gold and or silver by the Federal Government and not by an outside foreign entity.

**8. FREEDOM FROM EXCESSIVE TAXATION, AND OPPRESSIVE REGULATIONS.** Including the official repeal of the non-constitutional and illegal progressive Federal Income Tax (Amendment 16, which was never fully ratified.)

\* Proposing a 10% flat Federal excise sales tax for all businesses and all citizens on all goods and services (except food) with no exemptions or deductions. (See below for proposal details)

**9. A STRONG NATIONAL DEFENSE.**

**10. ACCOUNTABILITY/EQUALITY.** One law for all people, including government officials, to which all will be held equally accountable to a jury of their peers for their actions regardless of race, sex, religion, party affiliation, financial means, cultural heritage, etc.

**11. TERM LIMITS, PAY LIMITS, NO SPECIAL INSURANCE PLANS OR EXEMPTIONS, AND NO RETIREMENT BENEFITS FOR ELECTED GOVERNMENT OFFICIALS.**

**12. COMPLETE & INDEPENDENT US SOVEREIGNTY.** The United States should be independent and self sufficient as much as possible, including energy, manufacturing & production, defense manufacturing, & food independence.

**13. THE RETURN OF THE UNITED STATES TO A DEMOCRATIC REPUBLIC.** This includes opposition to, and the repeal of Socialism, Fascism, Maoism, Communism, Progressivism and the welfare state.

**14. LEGAL, ORDERLY AND CONTROLLED IMMIGRATION.** This includes securing all United States borders against all illegal immigration, and that this to be considered an issue of national defense.

**15. FREEDOM, EQUALITY, ACCOUNTABILITY, AND THE PURSUIT OF HAPPINESS** means; That all U.S. citizens are equal in the law in being free to have the opportunity to succeed or fail, to suffer the consequences of their failures, or to enjoy the fruits of their successful labors according to their individual or collective talents, abilities, and energies.

**PLANK #8 DETAILS: ELIMINATE/REPEAL INDIVIDUAL AND CORPORATE PROGRESSIVE INCOME TAXES. Replace it with a 10% NATIONAL EXCISE (SALES)**

## **TAX on all products and services except food.**

Under this plan there are no exemptions, no complicated tax returns. (Therefore a reduction of the IRS by 75%, saving \$8 billion dollars. (Businesses would collect the taxes the same way that they do current sales taxes, send them to the state, and then the state would send them to the Federal government. Under this system, there would be no Federal tax monies sent back to or into the States for “projects.” The states would fund all of their own projects.

[This would help eliminate a tremendous part of the fiscal and power abuse at the Federal level.) In other words... Texas, Ohio, Florida, etc. would not be forced to pay for a senators pet \$300 million project in Louisiana... unless the governor/state legislators of Texas, Ohio, Florida, etc. specifically gave the money to Louisiana for the project.

*(Example.. There would be no federal gasoline tax. (Currently 18.4%) The states would be free to increase their own gasoline taxes, or reduce them accordingly.)*

This would put the emphasis back to states control of the federal budget where it was originally. (Originally, Senators were not popularly elected but appointed and controlled by the states...thereby helping the states to have a more active part and control over the Federal government.)

–With an estimated \$14.5 billion current GDP... this would generate \$1.5 TRILLION in excise tax revenues. (Replacing \$1.6 trillion in personal/commercial income taxes.)

– This would also stimulate the economy like nothing else. (Going from 40% avg tax [for those who pay currently] to 10%.]

## ADDITIONAL IDEAS:

**\*\*THE REPEAL OF ALL STATE/FEDERAL PROPERTY TAXES** (Federal, State, and Local) on the basis that such property taxes are unconstitutional. (If a government entity can take your property or force you to pay to keep your property...then it is not really your property. )

**\*\*EMPLOYMENT TAXES REDUCED... (\$814 BILLION). BY HALF TO \$400 BILLION INITIALLY.** Eventually, all Federal employment taxes would be eliminated...and left to the states to levy, and administer.

**\*\*IMMEDIATELY REDUCE THE FEDERAL GOVERNMENT BUDGET BY \$600 BILLION DOLLARS.** (Initially return to 2006/2007 budget levels on the way to balancing the budget).

**\*\*THE IMMEDIATE REPEAL OF CLIMATE BILL TAXES, HEALTH BILL TAXES AND ALL OTHER TAXES ENACTED SINCE 2007.**

**\*\*INITIALLY REDUCE ALL FEDERAL AGENCIES BY 20% ACROSS THE BOARD.** except for Defense and Social Security. Social Security/medicare/medicaid to be frozen at Jan 2009 levels. No auto increases. (Eventually, Social Security, Medicare, Medicaid are to be either taken over by the states or privatized ...and taken out of the Federal government's hands.)

\* The elimination of several Federal departments...especially those departments that compete with the private sector.

-Including... National Endowment of the Arts, Federal Education dept, Fanny Mae, Freddie Mac, Federal Home Loan, and others.

**\*\*FREEZE THE UNSPENT BAILOUT & STIMULUS MONIES.** Go after "loans" and recover as much money as possible from the private individuals and companies it was illegally/unconstitutionally given to.

**\*\* ELIMINATE ALL PAYMENTS TO THE UNITED NATIONS** and withdraw from that organization, (\$1.5 billion dollars), and eliminate all payments to foreign nations and organizations that oppose the United States or offer no definable strategic purpose. (\$22.8 billion dollars of which \$2.5 billion goes to Israel.)
